

## Terms and Conditions

### 1. Object of Agreement

1. AZ.pl Inc. - in the following AZ.pl - is an official registrar for domains, accredited by Internet Corporation for Assigned Names and Numbers (in the following ICANN) as well as other national and international Registries. In this capacity AZ.pl registers Domains on a "first come, first served" basis.
2. All services of AZ.pl are only accepted on the basis of these terms and conditions, the information provided on the website, and – in case of domain registrations - the registration rules of the appropriate registry cited in the annex to this document.
3. Customers Terms and Conditions are only accepted if AZ.pl has provided their consent in written form.
4. Modification in Terms and Conditions and fees
  - 4.1. Changing the amount of fees or the contents of the Terms and Conditions will be announced through publication on the [www.az.pl](http://www.az.pl). It is allowed to notify customers of these changes electronically by AZ.pl
  - 4.2. AZ.pl reserves the right to introduce modifications to the Terms and Conditions at any time. New rules or amendments to existing Regulations come into force on the date of their publication on the [www.az.pl](http://www.az.pl), and all prior orders in this regard are hereby repealed.
  - 4.3. About modifications to the Terms and Conditions AZ.pl will notify through AZ.pl's customer control panel. .
  - 4.4. Notice of User shall be deemed effective after 14 days of notification.
  - 4.5. Existing Users have the right to refuse consent to an amendment or new Regulations within 14 days from the date of effective notice.
  - 4.6. Refusal to consent to the introduction of new provisions shall be valid unless made in writing to AZ.pl before the deadline specified in the preceding sentence. If you do not refuse to submit in due time and form shall be deemed to have consented to the new provisions.
  - 4.7. Renewal of the subscription for domain name registration provided under these Regulations shall be construed as acceptance of the amendments to the Rules.
  - 4.8. Members who are within the prescribed time limit and refused to consent to a new version of the Rules can benefit from services provided on the basis of the existing rules until the end of the period for which the contract was concluded or to which the subscription was paid, except that the notice of change or introduction of new Regulations will show that to refuse your consent, this contract is terminated.
  - 4.9. Changing the Rules or the issue of new Regulations by AZ.pl during the existing contract with customer, can take place:
    - 1) to improve the functionality of the service,
    - 2) to increase the security of the site and its users,
    - 3) in the event of rulings or changes in the law by competent state authorities resulting in the necessity of introducing changes to the services provided by AZ.pl,
    - 4) for changing the rules of registration of domain names,
    - 5) In the event of changes in the structure and internal organization of AZ.pl,
    - 6) in other justified cases.
5. The customer is obliged to read and save these Terms and Conditions, as well as the respective appendixes which are relevant to the customer. AZ.pl will keep a

current version of these terms and conditions available on their web pages.

## **2. Contract**

1. The AZ.pl webpage [www.az.pl](http://www.az.pl) constitute an invitation for customer contract applications that is subject to change. A contract can be closed through electronical confirmation of the application by AZ.pl or if the purchase is fulfilled. Mere use of the website or confirmations of receipt of application shall not be considered to constitute a contractual relationship with AZ.pl.
2. If the purchase should only partially be deliverable, then customer will also accept a part-delivery.
3. The object of the agreement and scope and description of services shall be defined by the actual contracts.
4. Customer is obliged to check the order confirmation from AZ.pl and must contact AZ.pl immediately should any mistakes be verifiable.

## **3. Domain registration and renewal of registration**

1. AZ.pl registers domains as an official registrar accredited by ICANN. Providing or administering domains AZ.pl acts however only as a mediator between the customer and ICANN or another institution or company in charge of the administration of the central data base. It has no influence on the distribution process of domain names. As there might be rights of a third party involved AZ.pl has no obligation to guarantee the continuity of the existence of a registered domain.
2. The customer assures that the domain name and the use of the domain does not interfere with or infringe the rights of a third party and that there are no other legal or factual obstacles to register the domain name, that the chosen name does not contradict morality and that the order conforms to the registration policies of the relevant registry. AZ.pl has no duty to verify the application in this respect.
3. The different Domains are administered by various different, usually national organisations (Registries). Each of these organisations have different terms and conditions relating to the registration of the respective Domains, as well as the proceedings in domain name dispute matters. AZ.pl is required to pass on these policies to their customers. Likewise, customers acting as resellers are required to oblige their customers to follow registry policies. As far as Domains are the subject of the contract, the additional terms and conditions of each gTLD and ccTLD apply as actual parts of the agreement. The customer acknowledges that the registration of the domain can be revoked due to policy violations at any time.
4. The customer further acknowledges that registry policies may change at any time and that he will keep himself informed about the current rules. AZ.pl will provide information on essential changes by email, and will provide a link to the most

current policies on their website.

5. When registering or transferring a domain the customer provides AZ.pl with the power of attorney to submit all updates done through AZ.pl (e.g. DNS Updates, WHOIS-Updates, as well as other domain configuration) on his behalf directly to the respective registry in real-time.

#### **4. Domain Name Dispute Policy and Exemptions**

1. The customer agrees to clarify and settle any disputes according to the Dispute Resolution Policies of the respective responsible Organisations. These Policies can be viewed on the Website of AZ.pl – [www.az.pl](http://www.az.pl). The language in the Policies may differ depending on the mother tongue of the country.
2. The customer accepts that AZ.pl acts as an accredited registrar and might be bound to lock, cancel a domain or to transfer it to a third party - according to UDRP-regulations - if the customer does not provide evidence within ten days after an Administrative Panel's decision, that he has commenced a lawsuit against the complainant in a Mutual Jurisdiction regarding the right to use the disputed domain name.
3. For the adjudication of disputes concerning or arising from use of the Registered Name, the Registered Name Holder shall submit, without prejudice to other potentially applicable jurisdictions, to the jurisdiction of the courts (1) of the Registered Name Holder's domicile and (2) where Registrar is located.
4. During a pending administrative proceeding or during a period of fifteen (15) days after such proceeding is concluded or during a pending court proceeding or arbitration commenced regarding the domain name the customer may not transfer the domain name registration to a third party unless the third party agrees, in writing, to be bound by the decision of the court or arbitrator.

#### **5. Liability and Force Majeure**

1. As a condition of the customer's access and use of the registration service and other services the customer agrees to defend, indemnify, save and hold harmless AZ.pl, agents, partners, ICANN, the central registry as well as all persons involved in the registration process in respect to all claims, demands, liabilities, costs and/or expenses resulting from an illegal use of a domain name registered by the customer or the content provided on a registered domain. In the event of a claim, customer has the right to prove AZ.pl, that claims in the context of the exemption have not occurred in the demanded extent or not at all, and / or the customer is not responsible.
2. AZ.pl, agents, partners, ICANN, the central registry nor any person involved in the registration will be liable to the customer or any third party for any direct or indirect loss of profits, earnings or business opportunities, damages, expense, or costs resulting directly or indirectly from any failure to perform any obligation or provide

service hereunder because of any Force Majeure, or governmental acts or directives, strikes, riot or civil commotion, war, any natural disaster, equipment or facilities shortages which are being experienced by providers of telecommunication services generally, or other similar force or condition beyond AZ.pl reasonable control.

3. AZ.pl cannot be held liable for delays of services and server downtimes due to higher force, fault of third parties or due to events, which AZ.pl has no influence on, despite any agreed upon deadlines and dates. You hereby permit AZ.pl to postpone the service-supply and/or achievement by the duration of the respective disruption plus an appropriate starting time. Furthermore AZ.pl can limit the service, if the stability and security of the operation, the maintenance of the net integrity, in particular the avoidance of serious disturbances of the network, the software or stored data requires it.
4. Concerning registration of multilingual domain names AZ.pl does not have any control of these registrations and it might be possible that the service will be modified, interrupted or even terminated by the registry without prior notice. AZ.pl has no obligation to guarantee the continuity of the existence or availability of multilingual domain names and registration is on customers own risk. The customer acknowledges, that the functionality of multilingual domains is not the same as regular domains. Furthermore the customer also acknowledges, that a multilingual domain, due to the introduction of constantly new technical features, may not function at all.
5. For all services of AZ.pl liability will be limited to intention and gross negligence.
6. In case of paid services adhesion is limited by AZ.pl with negligence and rough negligence to the amount of the payment which can be paid in each case from the customer for the respective achievement and/or achievement period. Negligence. In every other case, liability is capped at the amount of damage that are typically foreseeable at the time the agreement.
7. The customer is liable for all damages resulting from violations of the registration policies or these terms of conditions, and shall indemnify AZ.pl from all claims or other impairments resulting therein.
8. The customer agrees to keep all passwords and access data received from AZ.pl for access to our Services secret and to inform AZ.pl once he receives any information about unauthorized parties gaining access to these passwords. The customer acknowledge that he is responsible for any orders or statements issued with his user-identification and that he bears the risk of unauthorized use of his access data. Should unauthorized third parties use AZ.pl services while using his account, the customer is responsible for all fees and damages. AZ.pl may lock access to an account if there is sufficient reason to assume it is used by unauthorized parties. AZ.pl will inform the customer without delay of any such measure taken.
9. In case of allowed use by third parties or resale of products and services or AZ.pl to third parties, the customer is liable for any claims resulting from violations of the contract terms by the third party.

## 6. Duration of Contract and Termination

6.1. The contract for the maintenance of the domain name is concluded for an indefinite period.

6.2. The Agreement may be terminated by the Subscriber without identifying the cause and without the period.

6.3. Termination of the agreement must be done in writing.

6.4. Right to terminate the agreement by the Subscriber may be limited, the detailed provisions of the Rules of promotion.

6.5. The provisions of the rules and regulations of the service and promotion rules may include special rules for the Subscriber terminates the contracts.

6.6. In any case, refund, in the case of a VAT invoice, subject to refund is to sign a credit memo.

6.7. AZ.pl has the right to terminate the contract with immediate effect in the absence of timely payment by the user fee.

6.8. AZ.pl reserves the right to terminate the Agreement to maintain the domain name (registration agreement), which through its content, or content of a website on which indicates the content or the data contains any illegal, threatening the health or life, violates the rights of third parties, especially Copyright, contains the words generally considered offensive, inciting racial hatred or discrimination against other people when it is used directly or indirectly in the business of sending unsolicited commercial)

6.9.

a) AZ.pl terminates the contract for the maintenance of the domain name is the date the domain was paid for by the Subscriber prior to its termination.

b) AZ.pl reserves the right to remove a domain name with Domain Name System without notice period.

c) The termination of the contract does not limit the right of the Subscriber to transfer the domain name to another Registrar.

## 7. Data and Protection of Data

1. The customer is committed to supply AZ.pl with the following information and data. The customer assures that all submitted data and information to AZ.pl is correct and complete. By changing the data in the customer control panel, the customer furthermore assures that these modifications are correct, complete and truthful. The customer acknowledges that the indication of incorrect data can lead to the immediate deletion of the respective domain without refund. This concerns in

particular

- his full name, postal address, E-Mail address, telephone number, pesel number and fax number if available - if the registrant is an organization, association, or corporation - additional information on name and address of an authorized person for contact purposes, NIP number (VAT number);
- if the customer intends to use an own Domain Name Server (DNS): the IP-addresses of the first and secondary server;
- the names of these servers;
- the full name, postal address, E-Mail address, telephone number, and fax number if available of the administrative contact;
- the full name, postal address, E-Mail address, telephone number, and fax number if available of the technical contact; and
- the full name, postal address, E-Mail address, telephone number, and fax number if available of the billing contact.

The information has to be modified if necessary.

2. AZ.pl attaches the highest importance to protecting the privacy of data transmitted by users, in particular against unauthorized access. Each User using the resources and opportunities for site services AZ.pl consent to the processing of data directly related to the operation site and in other cases provided for by law. Opening and viewing the site services AZ.pl are accepting this Privacy Policy.
3. AZ.pl is authorized to use the data for improvement of its services and to even better adapt its services to the needs of the customers.
4. AZ.pl may also permanently save all data required for billing of services.
5. The customer has the right to be informed free of charge on the storage of his personal data.
6. The customer agrees to receive informational and marketing E-Mails directly from AZ.pl.
7. Additional information about protecting and maintenance of personal data are indicated in Regulamin usług AZ.pl, placed at [www.az.pl](http://www.az.pl)

## 8. Pricing

1. The prices for domain registration and extensions and other services of AZ.pl are published on – [www.az.pl](http://www.az.pl) ; these prices can be changed at any point in time.
2. Prices for renewals of domains are only valid for the actual price on the day of the transaction.

## **9. Payment**

1. You may pay for the service using the online payment through Dotpay, Paypal, credit card or bank transfer. Current payment channels are available on the site <http://www.az.pl>.
2. In the case of selection by the User bank transfer, you may receive an invoice pro-forma.
3. Payment of less than is apparent from the contract does not entail obligations AZ.pl to provide a service for which the payment was done.
4. Within seven days from the date of receiving appropriate amount at the AZ.pl's bank account, AZ.pl issue a VAT invoice to the customer control panel.
5. AZ.pl authorizes issue of an invoice without the signature of the recipient.
6. When the customer will make a payment in the amount higher than the price for the service specified in the contract, at the request of the User, AZ.pl shall refund the overpayment to indicated bank account or the overpayment will fund balance at AZ.pl's customer control panel.
7. AZ.pl has no obligation to credit the overpayment against the obligations specified by the user.
8. Discounts on services, together with promotional codes can be combined, but the amount of rebate shall not exceed 15%.

## **12. Final Clauses**

1. Modifications to the terms and conditions or the contract, as well as cancellations will only be accepted in writing, including E-Mail transmission, oral agreements shall not be considered valid.
2. For commercial customers and legal entities in Poland, as well as for all customers without permanent residence in Poland will be the exclusive place of jurisdiction, as well as the place of fulfillment.
3. For the contract between AZ.pl and its customers the Polish law is the only effective law.
4. If any provision of these terms and conditions shall be unenforceable and/or invalid, such unenforceability and/or invalidity shall not render these terms and conditions unenforceable or invalid as a whole. Any provision determined to be unenforceable or invalid shall be replaced by provisions which are valid and enforceable and closest to the original objectives and intents of the original provisions in an economic and legal sense that would have been agreed upon by the parties, had they known of the invalidity at the time of the agreement.
5. English version of these "terms and conditions" is valid.

To register a domain name, you are required to provide the name you are registering; your name and postal address (or those of the person for whom you are registering the name); technical information about the computer with which the domain name will be associated; and the name, postal address, E-Mail address, and voice and (where available) fax telephone numbers for the technical, administrative, billing, and zone contacts for the domain name. Once the domain name has been registered, your registration agreement requires you to correct and update this data promptly.

11. **Why you must provide the information.**

The information you provide when registering a domain name (or correcting or updating registration information) is required to allow the Internet to associate the domain name with your computer, for the initiation of a contractual relationship with AZ.pl as well as billing and invoicing, to allow us to properly handle your account (including notifying you at renewal time), and to permit others operating or using the Internet to easily contact you to resolve issues that arise in connection with the domain name.

12. It will also be stored under a data escrow program to keep the domain name operating in the event we leave the domain-name registration business. When you submit a question to our website, contact information is needed so that we can respond.

13. **Who will receive the information.**

We will provide information you submit in registering a domain name or updating related information to our own employees and consultants, to the administrator of the registry for the top-level domain in which you are registering, to operators and users of the Internet making.

14. Whois queries concerning your domain-name registration, to the Internet Corporation for Assigned Names and Numbers (ICANN) (which provides technical coordination for the Internet), and to escrow agents, auditors, Whois service providers, and replacement registrars that ICANN may designate. Information you provide in asking questions about our service may be given to our employees and consultants and, upon its request, to ICANN.

15. **Further use of the data.**

Use of the data for advertizing, customer support or market research shall be done



by AZ.pl only if required and only at the prior agreement of the customer. The customer shall be entitled to revoke his agreement for such use at any time. AZ.pl is entitled within the legal provisions to disclose such informations to law enforcement agencies and courts.

**16. Accessing, correcting, and updating information.**

You are required to correct any erroneous or out-of-date contact information concerning you registration. You can access the information you provide, correct it, and update it by visiting our website.

**Information you provide about others.**

In providing personal information about other individuals (such as someone in whose name you are registering or the domain name's technical or billing contacts), you represent that you have notified them of the purposes for which the information will be used, the recipients of the information, and how they can access and correct the information, and that you have obtained their consent.

Registrations in the .biz TLD must be used or intended to be used primarily for bona fide business or commercial purposes. For purposes of the .biz Registration Restrictions bona fide business or commercial shall mean the bona fide use or bona fide intent to use the domain name or any content, software, materials, graphics or other information thereon, to permit Internet users to access one or more host computers through the DNS:

1. To exchange goods, services, or property of any kind;
2. In the ordinary course of trade or business; or
3. To facilitate (i) the exchange of goods, services, information, or property of any kind; or, (ii) the ordinary course of trade or business.

Registering a domain name solely for the purposes of (1) selling, trading or leasing the domain name for compensation, or (2) the unsolicited offering to sell, trade or lease the domain name for compensation shall not constitute a "bona fide business or commercial use" of that domain name.

Registrants in the usTLD must be either:

1. A natural person
  - who is a United States citizen,
  - who is a permanent resident of the United States of America or any of its possessions or territories, or
  - whose primary place of domicile is in the United States of America or any of its possessions *[Nexus Category 1]*,
2. A United States entity or organization that is
  - incorporated within one of the fifty (50) U.S. states, the District of Columbia, or any of the United States possessions or territories, or
  - organized or otherwise constituted under the laws of a state of the United States of America, the District of Columbia or any of its possessions or territories (including a federal, state, or local government of the United States or a political subdivision thereof, and non-commercial organizations based in the United States) *[Nexus Category 2]*, or
3. A foreign entity or organization that has a bona fide presence in the United States of America or any of its possessions or territories *[Nexus Category 3]*.

Prospective Registrants will certify that they have "a bona fide presence in the United States" on the basis of real and substantial lawful contacts with, or lawful activities in, the United States of America. This requirement is intended to ensure that only those individuals or organizations that have a substantive lawful connection to the United States are permitted to register for usTLD domain names.

It shall be a continuing requirement that all usTLD domain name Registrants remain in compliance with Nexus. To implement the Nexus requirement, NeuStar will:

- Require that Registrars certify that they enforce the Nexus requirement upon their Registrants, and that Registrars require Registrants to certify that they meet the Nexus requirement.
- Conduct a scan of selected registration request information.
- Conduct "spot checks" on Registrant information
